The meeting was called to order by Chairman Michael Hawkins. Other members present: Vice Chairman David Tryc, Mr. Martin Timkovich, Mr. William Butts, Mr. Phillip Mitchell, and Ms. Donijo DeJonge. Absent: Mr. Nathaniel Moody.

Also present: Ms. Peggy Korzen, Executive Director of the Retirement System, and Mr. Thomas Michaud, Legal Advisor to the Board.

Mr. Butts made the motion to excuse the absence of Mr. Moody. The motion was seconded by Vice Chairman Tryc and carried.

There were no public comments regarding agenda items.

## The motion carried.

Ms. Korzen presented the Public Act 314 Asset Analyses showing a market value of \$482,415,379 on May 31, 2021 and \$488,988,383 on June 30, 2021. The reports were received and filed by the Chairman. (Analyses found on pages

Ms. Korzen next presented Trustees with the Quarterly Report of Account Refunds for the period 04/01/21 - 06/30/21; she noted that no former members withdrew their contributions and interest. The report was received and filed by the Chairman. (Report on page

The Executive Director presented Trustees with the Quarterly Report of Income for the quarter ending 06/30/21. Total Securities Lending income for the period was \$16,437.29. There were no Class Action Settlements for the period. Chairman Hawkins received and filed the report. (Report on page

Ms. Korzen commented that there is one potential disability retiree re-exam from 2020 and two potential disability retiree re-exams for 2021. Chairman Hawkins suggested going into closed session to discuss the issues surrounding the potential re-examinations. Mr. Butts made the motion to go into closed session to discuss the potential disability retiree re-exams, as this contains information that is exempt from the Freedom of Information Act and is also medically privileged, and to include Ms. Korzen, Mr. Michaud, and Ms. Balkema. The motion was seconded by Mr. Timkovich and carried. Roll call vote: yeas: 6, nays: 0. Trustees concluded their closed session and re-entered open session. Following Trustee discussion, Mr. Timkovich made the motion to waiver Ms. Phyllis Armstrong based upon her individual circumstances and medical information and to have the medical records for Mr. John Bolinger and Mr. Richard Troeger reviewed by one of the Board's physicians and proceed with a re-examination if warranted. The motion was seconded by Mr. Butts and carried.

There were no public comments on items not on the agenda.

Ms. Korzen commented that at the June Board meeting, it was unclear at that time as to which investment management account funds should be transferred from for Cash Account needs for August and September 2021. After recent review of the investment accounts, Mr. Lindberg and the Executive Director agreed to transfer \$1,400,000 from the Neuberger Berman account and \$450,000 from the NTAM account to the Cash Account on August 2, 2021, and \$1,000,000 from the Harding Loevner account and \$850,000 from the NTAM account to the Cash Account on September 1, 2021.

The meeting adjourned at 8:12 a.m.
