MINUTES REGULAR MEETING FEBRUARY 19, 2020 – 10:18 a.m. 233 East Fulton Street

Ms. Korzen presented the Public Act 314 Asset Analysis showing a market value of \$430,306,431 on December 31, 2019. The report was received and filed by the Chairman. (Analysis found on page)

Trustees reviewed an Eligible Domestic Relations Order (EDRO) for Mr. Brian W. Haner. Ms. Korzen stated that an EDRO has been filed to assign a portion of Mr. Haner's retirement benefits to an alternate payee, Desiree Gauthier Six, in accordance with the Eligible Domestic Relations Order Act. The EDRO has been reviewed by legal counsel and the actuary and complies with the General Retirement System plan provisions. The EDRO will become part of Mr. Haner's file and will be paid according to its provisions. The order was received and filed by the Chairman.

The Executive Director presented Trustees with the Quarterly Report of Income for the quarter ending 12/31/19. Total Securities Lending income for the period was \$24,920.05. Total Class Action Settlement receipts for the period were \$35.03. Chairman Hawkins received and filed the report. (Report found on page)

There were no public comments on items not on the agenda.

Ms. Korzen commented that at the December Board meeting, it was unclear at that time as to which investment management account funds should be transferred from for Cash Account needs for March 2020. After recent review of the investment accounts, Mr. Lindberg and the Executive Director agreed to transfer \$1,305,000 from the NTAM account and \$500,000 from the PIMCO account to the Cash Account on March 2, 2020.
