- Payment of Legal Services fees of \$19,620.00 to VanOverbeke, Michaud & Timmony, P.C. for the period 01/01/17 12/31/18. Mr. Balkema commented that the Retirement System receives excellent legal service at a reasonable cost.

The motion carried.

Ms. Korzen noted that the Public Act 314 Asset Analysis for December 31, 2018 was not ready to be distributed to Trustees due to a delay in Northern receiving statements from some of the investment managers.

Ms. Korzen next presented Trustees with the Quarterly Report of Account Refunds for the period 10/01/18 - 12/31/18; two non-vested members withdrew their contributions totaling \$752.28. One KEIP member withdrew his KEIP funds totaling \$50,983.03 from the Police & Fire Retirement System. The report was received and filed by the Chairman. (Report on page

The Executive Director presented Trustees with the Quarterly Report of Income for the quarter ending 12/31/18. Total Securities Lending income for the period was \$20,563.57. Total Class Action Settlement receipts for the period were \$196.67. Chairman Hawkins received and filed the report. (Report found on page

Ms. Korzen next addressed the duty disability retirement request by Police Officer Marc J. Miller that was tabled at the December 19, 2018 Board meeting. Mr. VanderPloeg made the motion to approve Mr. Miller's duty disability retirement request, as there is now a majority opinion by the medical committee stating Mr. Miller is totally and permanently disabled and should be retired. The motion was seconded by Vice Chairman VanderWall and carried. Chairman Hawkins thanked the Millers for their patience during this process and wished Mr. Miller the best.

There were no public comments on items not on the agenda.

Ms. Korzen commented that at the December Board meeting, it was unclear at that time as to which investment management account funds should be transferred from for Cash Account needs for February 2019. After recent review of the investment accounts, Mr. Ford and the Executive Director agreed to transfer \$1,575,000 from the Baird Advisors account to the Cash Account on February 1, 2019.

Vice Chairman VanderWall made the motion to nominate Mr. Michael Hawkins to serve as Chairman of the Board of Trustees for the year 2019; the motion was seconded by Mr. Balkema and

carried. Mr. VanderPloeg made the motion to nominate Mr. Craig VanderWall to serve as Vice Chairman of the Board of Trustees for the year 2019. The motion was seconded by Mr. Balkema and carried.

The Executive Director commented that Mr. Thomas VanderPloeg and Ms. Donijo DeJonge reviewed the annual accounting for the fiscal year ending 12/31/17 and noted no discrepancies. {Mr. Moody arrived at 8:04 a.m.}

The meeting adjourned at 8:05 a.m.
