Ms. Korzen stated that it would be prudent to update the authorized parties resolution to list herself, Chairman Hawkins and Vice Chairman Tryc as authorized parties to sign contracts and issue directions to the investment managers and other providers. Vice Chairman Tryc made the motion to approve the authorized parties resolution. The motion was seconded by Mr. Butts and carried.
