#### The motion carried.

Ms. Korzen next presented a report of Cash Account transfers for the period 07/01/21 - 09/30/21. The Retirement Systems Office staff projected a need for \$2,525,000 to be transferred to the cash account as follows: \$1,000,000 on August 2<sup>nd</sup> and \$1,525,000 on September 1<sup>st</sup>. Ms. Korzen stated that the transfers will be reviewed with Wilshire Associates as it gets closer to their due date:

Ms. Korzen noted that there will be no transfer required for July due to the receipt of the large distribution from the Aberdeen Asset Management account. The report was received and filed by the Chairman. (Cash Account Report found on page )

Ms. Korzen presented the Public Act 314 Asset Analysis showing a market value of \$503,220,229 on April 30, 2021. The report was received and filed by the Chairman. (Analysis found on page )

Trustees reviewed a Domestic Relations Order (DRO) for Mr. Richard W. Dame. Ms. Korzen stated that a DRO has been filed to assign a portion of Mr. Dame's retirement benefits to an alternate payee, Marybeth Dame, in accordance with the Eligible Domestic Relations Order Act. The DRO has been reviewed by legal counsel and complies with the Police & Fire Retirement System plan provisions. The DRO will become part of Mr. Dame's file and will be paid according to its provisions. The order was received and filed by the Chairman.

The actuarial services retainer fee from Gabriel, Roeder, Smith and Company (GRS) for the period of 07/01/21 - 06/30/22 was presented to Trustees. The annual fee requested is \$36,160, in quarterly increments of \$9,040, which represents a 3.1% increase from last year's fee. GRS has requested a fee (shared with the City) not to exceed \$13,000 for GASB 67/68 required reporting. Mr. Balkema made the motion to approve the renewal retainer fee request with Gabriel, Roeder, Smith and Company. The motion was seconded by Vice Chairman VanderWall and carried.

Mr. Paul Matz of Rehmann Robson presented Trustees with the annual audit for the fiscal year ending December 31, 2020. Mr. Matz noted that based upon the controls presently in place, there are no issues. Mr. Matz highlighted some of the features of the statements; he noted that there were no issues with the Retirement Systems Office staff. He also reviewed some of the highlights from the Management's Discussion and Analysis and the Notes to Financial Statements sections. He reviewed the Independent Auditors' Report on Internal Controls provided by Rehmann and presented some of its highlights. The report was received and filed by the Chairman.

There were no comments on items not on the agenda.

The meeting adjourned at 8:13 a.m.
