MINUTES REGULAR MEETING MARCH 15, 2023 – 9:17 a.m. 233 E. Fulton, Suite 216

The meeting was called to order by Chairman Michael Hawkins. Other members present: Vice Chairman David Tryc, Mr. Martin Timkovich, Mr. William Butts, Mr. Phillip Mitchell, and Mr. Nathaniel Moody. Absent: Ms. Donijo DeJonge.

Also present: Ms. Peggy Korzen, Executive Director of the Retirement System and Mr. Thomas Michaud, Legal Advisor to the Board.

Mr. Mitchell made the motion to excuse the absence of Ms. DeJonge. The motion was seconded by Vice Chairman Tryc and carried.

There were no public comments regarding agenda items.

Ms. Korzen next presented a report of Cash Account transfers for the period 04/01/23 - 06/30/23. The Retirement Systems Office staff projected a need for \$6,225,000 to be transferred to the cash account as follows: \$2,075,000 on April 3rd, \$2,075,000 on May 1st and \$2,075,000 on June 1st. Ms. Korzen recommended, and Wilshire agreed, making the transfers as follows:

Ms. Korzen presented the Public Act 314 Asset Analysis showing a market value of \$442,128,251 on January 31, 2023. The report was received and filed by the Chairman.

Roll call vote: yeas: 6, nays: 0. Trustees concluded their closed session and re-entered open session. Following Trustee discussion, Vice Chairman Tryc made the motion to re-examine Mr. Richard Troeger and to waive the re-examination for Ms. Barbara Singleton based upon her age and medical information. The motion was seconded by Mr. Moody and carried.
