Ms. Korzen presented the Public Act 314 Asset Analyses showing a market value of \$441,530,854 on August 31, 2020 and \$435,625,615 on September 30, 2020. The reports were received and filed by the Chairman. (Analyses found on pages

Ms. Korzen next presented Trustees with the Quarterly Report of Account Refunds for the period 07/01/20 - 09/30/20; one non-vested member withdrew his contributions and interest totaling \$12,503.76. The report was received and filed by the Chairman. (Report on page

The Executive Director presented Trustees with the Quarterly Report of Income for the quarter ending 09/30/20. Total Securities Lending income for the period was \$22,245.34. There were no Class Action Settlement receipts for the period. Chairman Hawkins received and filed the report. (Report found on page

There were no public comments on items not on the agenda.

Ms. Korzen commented that at the September Board meeting, it was unclear which investment management account funds should be transferred from for Cash Account needs for November and December 2020. After recent review of the investment accounts, Mr. Lindberg and the Executive Director agreed to transfer \$1,050,000 from the Wellington Management (equities) account to the Cash Account on November 2, 2020 and \$1,050,000 from the NTAM account to the Cash Account on December 1, 2020.

The Executive Director commented that there was only one nominating petition received for the Fire Member Trustee election this fall; therefore Mr. VanderWall is presumed re-elected. He will serve a four-year term that will expire the first Monday in January 2025. Chairman Hawkins thanked Vice Chairman VanderWall for his continued service to the Board.

The meeting adjourned at 8:08 a.m.
