MINUTES REGULAR MEETING NOVEMBER 15, 2023 – 10:41 a.m. 233 Fulton Street East

The meeting was called to order by Chairman Michael Hawkins. Other members present: Vice Chairman Justin Ewald, Mr. Philip Balkema, Ms. Donijo DeJonge, and Mr. William Fabiano. Absent: Mr. Phillip Mitchell and Mr. Nathaniel Moody.

Also present: Ms. Peggy Korzen, Executive Director of the Retirement System, Mr. Thomas Michaud, Legal Advisor to the Board, and Police Sergeant Keith Hefner.

Mr. Fabiano made the motion to excuse the absences of Mr. Mitchell and Mr. Moody. The motion was seconded by Vice Chairman Ewald and carried.

Police Sergeant Keith Hefner addressed the Board regarding the duty disability retirement request for his wife, Katie Hefner. He stated that he is a supervisor for the major case team at GRPD. Mr. Hefner wanted to highlight the discussion with Dr. Lamson in the Joint Board meeting and noted that Trustees should take the medical reports for Ms. Hefner at face value. He stated that the event did in fact happen at work and that after May 30, 2020 Ms. Hefner fought extremely hard to get past the event that caused her mental disability and sought help but has been unsuccessful. Mr. Hefner commented that the medical evaluation reports were very thorough and clearly laid out that Ms. Hefner's disability occurred on duty. He asked Trustees to make a decision today in order to be fair to Ms. Hefner, and thanked the Board for their time.

The motion carried.

Ms. Korzen presented the Public Act 314 Asset Analyses showing a market value of \$477,373,685 on August 31, 2023, and \$463,369,074 on September 30, 2023. The reports were received and filed by the Chairman.

Ms. Korzen next presented Trustees with the Quarterly Report of Account Refunds for the period 07/01/23 - 09/30/23; three non-vested members withdrew their contributions and interest totaling \$31,599.65. Nine former KEIP participants withdrew their KEIP funds totaling \$1,543,749.07. The report was received and filed by the Chairman.

The Executive Director presented Trustees with the Quarterly Report of Income for the quarter ending 09/30/23. Total Securities Lending income for the period was \$42,187.47. Total Class Action Settlement receipts for the period were \$57.24. Chairman Hawkins received and filed the report.

The Executive Director next addressed the duty disability retirement request from Police Officer Katie Hefner that was tabled at the October 18, 2023 special meeting. Following Trustee discussion, Mr. Balkema made the motion to approve the duty disability retirement request from Police Officer Katie Hefner based on the medical findings and reports that were presented. The motion was seconded by Vice Chairman Ewald and carried. Trustees thanked Ms. Hefner for her service and wished her well in her retirement.

The Executive Director next addressed the duty disability retirement request from Police Officer Curtis Creighton that was tabled at the October 18, 2023 special meeting. Following Trustee discussion, Mr. Balkema made the motion to approve the duty disability retirement request from Police Officer Curtis Creighton based on the medical findings and reports that were presented. The motion was seconded by Vice Chairman Ewald and carried. Trustees thanked Mr. Creighton for his service and wished him well in his retirement. Mr. Balkema thanked Chairman Hawkins and Ms. Korzen for the educational session from Dr. Lamson in the Joint Board meeting.

Ms. Korzen next presented an update on the disability retiree re-examination process, noting that Dr. Mira Jourdan-Krishnan conducted a medical records review for Mr. Gene Tobin and stated her opinion that Mr. Tobin is not physically and mentally able and capable of resuming his duty as a Police Officer and the incapacity is likely to be permanent; therefore, he should continue to be retired as disabled. Dr. John Anderson conducted a medical records review for Mr. Christopher Moleski and stated his opinion that Mr. Moleski is not physically and mentally able and capable of resuming his duty as a Fire Fighter and the

incapacity is likely to be permanent; therefore, he should continue to be retired as disabled. Dr. Joseph Burkhardt conducted a medical records review for Mr. James Watson and stated his opinion that Mr. Watson is not physically and mentally able and capable of resuming his duty as a Police Officer and the incapacity is likely to be permanent; therefore, he should continue to be retired as disabled.

There were no public comments on items not on the agenda.

Ms. Korzen commented that at the September Board meeting, it was unclear which investment management account funds should be transferred from for Cash Account needs for November and December 2023. After review of the investment accounts, Wilshire and the Executive Director agreed to transfer \$975,000 from the Wellington Management (Commodities) account to the Cash Account on November 1, 2023 and utilize \$400,000 from Private Equity/Private Credit distributions; and transfer \$950,000 from the Harvest Fund Advisors account to the Cash Account on December 1, 2023 and utilize \$425,000 from Private Equity distributions.

The meeting adjourned at 10:54 a.m.
