# MINUTES REGULAR MEETING SEPTEMBER 19, 2018 – 9:36 a.m. 233 East Fulton

The meeting was called to order by Chairman Michael Hawkins. Other members present: Mr. Thomas VanderPloeg, Mr. Philip Balkema, Mr. Philip Mitchell, Ms. Donijo DeJonge, and Mr. Nathaniel Moody. Absent: Vice Chairman VanderWall.

Also present: Ms. Peggy Korzen, Executive Director of the Retirement System, Mr. Thomas Michaud, Legal Advisor to the Board, Mr. Marc Miller, Ms. Kimberly Miller, and Ms. Gina Essex.

Chairman Hawkins welcomed Commissioner Nathaniel Moody to the Board as Employer Trustee.

Mr. VanderPloeg made the motion to excuse the absence of Vice Chairman VanderWall. The motion was seconded by Mr. Balkema and carried.

There were no public comments regarding agenda items.

Mr. Michaud requested to move up the duty disability retirement request for Police Officer Marc J. Miller since Mr. Miller has been waiting for quite some time. Chairman Hawkins presented the request for a duty disability retirement by Police Officer Marc J. Miller. Mr. Michaud suggested going into closed session to discuss the issues surrounding this case. Mr. Balkema made the request to go into closed session to discuss Mr. Miller's duty disability retirement request, information that is exempt from the Freedom of Information Act and is also medically privileged, and to include Mr. Marc J. Miller, Ms. Kimberly Miller, Ms. Gina Essex, Ms. Korzen, Mr. Michaud, and Ms. Balkema. The motion was seconded by Mr. VanderPloeg and carried. Roll call vote: yeas: 6, nays: 0. Following Trustee discussion, Mr. VanderPloeg made the motion to table the duty disability retirement request for Police Officer Marc Miller so that additional medical information can be received from Mr. Miller and shared with the medical committee for their review. The motion was seconded by Mr. Balkema and carried.

Ms. Korzen recommended, and Mr. David Lindberg of Wilshire Associates agreed, making the transfers as follows:

Ms. Korzen presented the Public Act 314 Asset Analysis showing a market value of \$428,177,544 on August 31, 2018. The report was received and filed by the Chairman. (Analysis found on page )

Ms. Korzen noted that the Annual Accounting for the General Retirement System for the period 07/01/17 - 06/30/18 was ready to be reviewed. She noted that it was decided by Trustees to review the Annual Accountings of both retirement systems at the same time each year, and therefore a committee should be established. Mr. VanderPloeg and Ms. DeJonge volunteered to serve. Chairman Hawkins noted that Ms. Korzen will coordinate a date to review the accountings and the Trustees will report their findings to the Board at a future Board meeting.

The meeting adjourned at 10:42 a.m.
