## Summary Report of Plan Operations/Expenses

How much does it cost to manage the General Retirement System? For the period 07/01/20 - 06/30/21, it cost the Retirement System approximately \$2.5 million. Most of this amount (\$1,869,211) was for investment manager fees. The balance of the expenses, \$603,986, paid for asset custody, auditors, actuaries, attorneys, independent medical evaluations, office rent, staff salaries and training. The costs to run the plan are 0.51% (51 basis points) of the market value of assets. All fees and expenses are paid in cash, as the Plan does not employ soft dollar arrangements. Audits, annual accountings, and actuarial valuations may be reviewed at the Retirement Systems Office.

Please note that any of the aforementioned changes <u>must be signed by the retiree</u>, unless he/she has a valid Power of Attorney document on file with the Retirement Systems Office.
