## Announcement Regarding the 13th Check

We regret to inform our retirees that there will not be a 13th Check Pension Supplement issued on January 31, 2025. The 13th Check may be issued annually, if funds are available, by the City of Grand Rapids General Retirement System to eligible retirees and beneficiaries. This check, a negotiated part of your retirement benefit, can only occur when the average annual market value rates of return for the investment of retirement system assets have experienced sufficient gains during the last five years to allow for the distribution of excess reserve funds. The five-year average market value rate of return was 7.77% for the General Retirement System. Per City Code, in order for a 13th Check to be issued, the five-year average market value rate of return must exceed 8.0%. Therefore, there are not sufficient reserves to issue a 13th Check on January 31, 2025. Although it is our hope that an annual distribution will occur, the economy, volatility of financial markets, and other considerations may not make it possible to do so.

### Need to Make Changes to Your Address, Direct Deposit or Withholding?

If you need to make changes to your address, direct deposit, or Federal or State withholding, please note that we require these—changes in writing, with your original signature (no computer generated signatures). Any of the aforementioned changes <u>must be signed by the person receiving the pension benefits</u>, unless a valid Power of Attorney document is on file with the Retirement Systems Office. If you spend the winter months elsewhere, you must notify us in writing when you leave and again when you return to avoid your pension correspondence being returned. Generally, our cutoff with Northern Trust for inputting changes on their system is around the middle of each month for the pension check that is generated at the end of that month. Listed below are our cutoff dates for the remainder of 2024 and early 2025:

November 15 December 17 January 17 February 14 March 18 April 17
